Thank you for your communication of 18<sup>th</sup> May 2017 regarding the BBF's YANG model developments. Specific to IEEE 802.3 Ethernet standards for MAC and PHY, the related active project is the IEEE P802.3.2 (IEEE 802.3cf) YANG Data Model Definitions Task Force (see <http://www.ieee802.org/3/cf>). The Task Force is in the process of creating its first draft. We anticipate having it ready for sharing in the September to November 2017 timeframe.

We look forward to further communications on YANG modeling for Ethernet and how all of these groups can work together in a coordinated fashion.
